The quotation should be submitted in the Tender box which will be kept in the chamber of The MSVP, by **12-30 P.M.** on **27/11/2019** and the same will be opened at 1.00 pm on the same date in presence of intended bidders.
No quotation will be accepted beyond the stipulated time and date under any circumstances.

The quotation will be subject to the following terms & conditions:

RESERVE RATE OF FISH IS Rs. 80/ per kg irrespective of type and size of fishes.

- (1) The rate in Indian rupees will have to be quoted both in words and figures including all taxes.
- (2) The rates will have to be quoted after inspecting the POND of the Hospital..
- (3) The undersigned have every right to reject or cancel any part of quotation without assigning any reason.
- (4) Selection will normally be made on H₁ basis, but it is not obligatory to accept H₁ rate always.
- (5) The quotations are to be submitted in a sealed cover marked with the quotation No and date.
- (6) The total process of fishing will be completed within seven (7) days from the date of receive of the order.
- (7) Everyday the fishing process will be completed within 5.30 a.m. to 7.30 a.m.
- (8) In the process of fishing all accessories will be arranged by the successful bidder for which no claim will be entertained.
- (9) Only net will be used for the above purpose, no chemical or pesticide can be applied.
- (10) Net gap size of ½ inch maximum will be allowed.
- (11)The day to day Payment must be made in full by cash/cheque on spot to the authorized person of the Hospital which will be deposited in the RKS A/C of NRSMCH .
